

入會須知

跟據二〇〇五年十二月本會會員大會通過之佰章修訂：

(甲) 會員分類：

- (一) **團體會員**：凡本港註冊的舞蹈團體、舞蹈學校、包括附屬於註冊社團、教育機構的舞蹈組，填具團體會員入會申請表格，由本會應屆理事簽名推薦，並連同社團註冊證明書副本一份，交回會籍秘書處，經理事會審核通過後，得成為本會會員，享有一票選舉權及被選權。
- (二) **個人會員**：凡對舞蹈界有貢獻或與舞蹈藝術有關之人士，填具個人會員入會申請表格，由本會應屆理事簽名推薦，交回會籍秘書處，經理事會審核通過後，得成為本會會員，享有一票選舉及被選權。
- (三) **會友**：凡對舞蹈有興趣或曾參加本會班組活動之非會員，可填具會友入會申請表格，(未滿 18 歲者，須由家長或監護人代表入會) 交回會籍秘書處，得成為會友，享有班組活動優待及有關舞蹈用品之優惠，無選舉權及被選權。

* 本會有權接受或拒絕入會申請，而毋須提出任何理由。

(乙) 會費：

繳交會費之年度，由每年一月一日至十二月三十一日止。

- (一) **團體會員**：首次入會費港幣三百元正，按年繳納會費港幣貳佰元正。
- (二) **個人會員**：首次入會費港幣二百元正，按年繳納會費港幣壹佰貳拾元正。
- (三) **會友**：免繳首次入會費，按年繳納會費港幣捌拾元正。
- (四) **永久會員**：凡本會個人會員一次過繳交港幣壹仟貳佰元可成為永久會員。(暫停申請)

(丙) 繳費辦法：

- (丁) **會員證**：已獲接受入會之人士，將由本會發出正式收據及會員證，每 5 年更換一次(永久會員除外)，凡會員參加本會舉辦之活動或班組，須出示會員證。

Notice to Applicants

The following four articles of the constitution were revised and passed in the general meeting of the Federation on Dec 2005.

(A) Categories of Membership:

(1) Group Membership -

Any registered dance association or dance school, including any dance group under a registered organization or an education institution, which has submitted a completed application form for group membership signed recommendation by any director of this year to the membership secretary, and whose application has been approved by the board of directors, shall be member of the Federation and be entitled to a vote of nominating and being nominated for election.

(2) Individual Membership -

Any person, who has contribution to the dance field or connection with the art of dance and who has submitted a completed application form for individual membership signed recommendation by any director of this year to the membership secretary, and whose application has been approved by the board of directors, shall be member of the Federation and be entitled to a vote of nominating and being nominated for election.

(3) Associate Membership -

Any non-member, who is interested in dancing or has joined classes or activities held by the Federation and who has submitted a completed application form for associate membership signed recommendation by any member or person-in-charge of a class to the membership-secretary, shall be member of the Federation and be entitled to privileges when joining activities and classes though not to the right to vote and to stand for election.

* The Federation reserves the right of accepting and rejecting an application for membership without stating any reason.

(B) Membership Fees:

The subscription year shall begin on 1 January and terminate on 31 December.

1. **Group Membership** -- The admission fee shall be **HK\$300 only**, and the annual subscription **HK\$200 only**.
2. **Individual Membership** -- The admission fee shall be **HK\$200 only**, and the annual subscription **HK\$120 only**.
3. **Associate Membership** -- The admission fee shall be fee, and the annual subscription **HK\$80 only**.
4. **Life Membership** -- An individual member who is willing to pay **HK\$1,200** can become a life member.

* The above membership fees shall be subject to the annual announcement of the Federation.

If admission is not granted, the membership fee paid by an applicant shall be returned wholly.

(C) Method of Payment:

(D) Membership Card:

Any person who has been granted admission shall be issued an official receipt and a membership card which shall be renewed annually. When a member takes part in activities or classes organized by the Federation, he/she shall have to present his/her membership card.
